



NATA District One Safe Sports School Award Grant Program Procedures and Application

Note: Only first-time applicants for the Safe Sports School Award are eligible for District One grants (i.e., no renewal applications).

- I. The athletic trainer from the candidate school will submit the following:
 - a. Completed [NATA Safe Sport School Award \(SSSA\) application](#) and any supporting documents.
 - b. Signed Declaration and Release.
 - c. Completed District One Grant Application Form (see page 3 of this document).
- II. Enrollment in the [Korey Stringer Institute A.T.L.A.S. Program](#) is highly encouraged.
- III. The District One Secondary School Athletic Trainer Committee (SSATC) Chair, District One Treasurer, and District One Secretary will review applications.
 - a. If the grant request is approved, the District One Treasurer will submit the school's application with the application fee of \$150 to the NATA, and notify the SSATC Chair and District One Secretary that the grant award has been paid.
 - b. The SSATC Chair will notify the athletic trainer who submitted the grant request that he or she has received the District One SSSA Grant, and their application has been submitted to the NATA.
- IV. SSSA winners will be notified via e-mail from the NATA.
 - a. The District One Director is notified by the NATA when a school in the District receives a SSSA. The Director will notify the District One Secretary, Treasurer, SSATC and PR Chairs of all SSSAs.
- V. The Chair of the District One Public Relations (PR) Committee will contact ATs at schools who receive the SSSA to coordinate publicity and press releases.

- a. The District One PR Chair will coordinate PR efforts with the PR Chair for the recipient's State Association.
 - b. Grant winners are encouraged to recognize District One as the funding source for the Safe Sport School Award grant in press releases, interviews, and other forms of publicity about the award.
- VI. All application materials must be submitted electronically to Denise Alosa, D1 Secondary School Committee Chair at dalosa@sbschools.net. Incomplete applications will be returned.

Applications are being accepted on a rolling basis, until funds approved by the District One Executive Council on June 27, 2017 are exhausted.
